We will ask Farm Bureau members to take action on proposed legislation to ensure the preservation and protection of Maryland agriculture.

### **SB12: Corporations and Associations – Annual Report Filing Fees – Electronic Filing Exemption**

*Senator Brooks, JPR at 1:00 PM*

This bill exempts business entities from paying the filing fee required with the submission of an annual report to the State Department of Assessments and Taxation (SDAT) if the annual report is filed electronically. This would include a farm.

### **SB29: Baltimore City Soil Conservation District - Establishment - Requirements**

This bill establishes provisions governing the establishment of a Baltimore City Soil Conservation District (SCD) pursuant to the authority provided under current law.

### **SB34: Department of Agriculture - State Ombudsman for Value-Added Agriculture**

*Senator Hester, EEE at 1:00 PM*

Value-added agriculture means (1) the alteration of a raw agricultural product in a way that increases the product's worth to a consumer and brings more revenue to a farmer, producer, or processor; and (2) includes all enterprises in which an agricultural business or the agricultural business's products are altered, marketed, produced, or processed in a way that adds income to a farmer, producer, or processor. The state ombudsman for value-added agriculture shall: (1) serve as the primary point of contact for individuals engaging in, or interested in engaging in, value-added agriculture in the state; (2) provide information regarding state and federal regulations relating to value-added agriculture; (3) act as a liaison between state and federal partners involved in value-added agriculture; and (4) perform any other duty or function that supports value-added agriculture in the state, as required by the secretary.

**SB124: Maryland Food System Resiliency Council**
