### Message to Members

I hope 2023 has started off well on your farm! The weather has certainly left us something to talk about. While some years bring record snow or cold temperatures, it seems we have not seen much of either this winter. While I certainly enjoy the warmer days, and not having to shovel snow or deal with ice, I hope it won't be something we pay for later when trying to get crops planted and growing.

At the beginning of February, myself and many other members of the Howard County agricultural community attended the Taste of Maryland Agriculture event at Live! Casino in Arundel Mills. Over 800 people were in attendance at this event, where legislative leaders were able to meet with farmers and talk about the business of farming. Governor Wes Moore, along Lt. Governor Aruna Miller, were both in attendance and shared an exciting and hopeful message with the farming community. It will be interesting to see what the next four years will bring, but I am hopeful that we have an administration that is open to continue supporting the business of agriculture in Maryland.

As I sit down to write my March message to members, we are not quite halfway through the 2023 legislative session in Annapolis. There were some who believed the current legislative session would be uneventful, with the start of a new administration and the turnover that brought some new legislators, however it has continued to be an interesting year in Annapolis, and many have kept a watchful eye on some of the new bills that have been introduced.

On February 8<sup>th</sup>, Maryland Farm Bureau hosted their annual Day in Annapolis event. This year had record attendance, both by farm bureau members, as well as legislators. Howard County was well represented. Along with myself, I would

like to thank the following who took the time away from their busy schedules to visit with our local legislators and talk about issues that impact agriculture: Zack Brendel, Mickey Day, Danielle Farace, Howie Feaga, Barbara Glenn, Kathy Johnson, and Jake Moore. While in Annapolis, we were able to personally visit with Senator Katie Hester and Senator Clarence Lam, Delegate Jessica Feldmark, Delegate Chao Wu and Delegate Natalie Ziegler. We also met with aides from offices of Senator Guy Guzzone, and Delegates Vanessa Atterbeary, Pam Lanman Guzzone and Jen Terrasa. Overall, it was a successful day full of good conversations about agriculture.

Highlights of some of the bills that were discussed include:

- The addition of a state specialist within Maryland Department of Agriculture for value-added agriculture
- An increase for on-farm composting to 40,000 square feet (currently 5,000 square feet), and to allow the incorporation of food scraps to the feedstock used in the compost pile
- Requirements for the sale of new zeroemission medium- and heavy-duty vehicles within the State
- For Howard County a reduced setback for the archery hunting zone (already in effect in other counties in the state)

To follow along with the 2023 Maryland General Assembly session, be sure to check your e-mail inbox for the MD Farm Bureau Hotline, sent weekly with legislative highlights. Also be sure to attend the Howard County Farm Bureau's Legislative Dinner on April 20<sup>th</sup> at the Howard County Fairgrounds. We look forward to getting final updates from our local legislators on this evening. Additional details regarding the dinner can be found later in this newsletter.

The Howard County Farm Bureau Board of Directors continue to also work hard behind the

scenes. In the past two months, there have been discussions about budget requests to the county for FY2023-2024, and well as some county farm bureau policy initiatives we would like to pursue on a local level. All of this information has been shared with representatives of the county. We hope that together we are able to accomplish some of these requests and goals to help promote and support agriculture in Howard County throughout the coming years.

In closing, I would like to congratulate Howie Feaga, who was the winner of the MD Farm Bureau Ford pick-up truck raffle. The announcement was made during our attendance at Day in Annapolis, and it made for a little more excitement during the day.

### Howard County Farm Bureau Scholarship

The Howard County Farm Bureau will offer one \$1,000.00 scholarship for someone in the 14 to 16 age range and another \$2,000.00 scholarship to someone in the 17 to 19 age range. The 17-19 scholarship will be partially funded by Farm Bureau and partially funded by the Jackie Bauer Memorial Scholarship fund. To be eligible for the 17 to 19 scholarship, they would either need to be a current HCFB member OR a current or former 4-H or FFA member. The 14 to 16 scholarship is open to HCFB members only.

To apply, students must return the attached application form (on page #11) and write an essay. The essay is to be written on:

"Plant based protein brands such as
Beyond or Impossible are now
commonplace in major fast-food
restaurants and grocery stores. How can
the agricultural industry embrace a
growing plant-based protein market and
traditional meat sources at the same
time?"

We would guide the winners to use the money for school and or 4H/FFA projects. The deadline for applications and essays is April 1, 2023

The Scholarships will be awarded at our annual Legislative Dinner

All decisions on the winner will be made by the Howard County Farm Bureau Board of Directors. Essays are to be written in number 12 font and be no longer than 2 pages with one inch margins.

### Maryland Farm Bureau Scholarships



Deadline March 24th, 2023

Agricultural and other students eligible for five \$2,000 scholarships

Maryland Farm Bureau (MDFB) is giving back to its members and students of the community by offering five \$2,000 scholarships for the 2023-2024 academic year. Applicants must be high-school seniors starting college in the fall of 2023 or full-time college students at any accredited community college or four-year institution. Applicants, or their parents/guardians, must be members of Maryland Farm Bureau.

Three of the scholarships will be awarded to students pursuing academic disciplines in food, agriculture, and/or natural resources. The

remaining two scholarships are open to students in any academic discipline.

Scholarship recipients will be selected by a designated committee of the Maryland Farm Bureau. Students must apply online via the <u>official application website</u>. The application includes the following essay question to be answered by each applicant:

How can Farm Bureau effectively support young farmers and ranchers to successfully prepare for an ever-changing economy and increasing infrastructure challenges?

Provide two examples, including one local program or initiative you have been a part of or been made aware of.

Online applications must be submitted by March 24 at 10:59 p.m.

Over a hundred seasonally-adorned horses — driven, under saddle, and led by side-walkers — made their way down the parade route! From draft horses, to saddle horses, to ponies and minis, groups such as the Saddle Gals and Guys Drill Team with their flags flowing high, Gentle Giants Draft Horse Rescue, Days End Farm Horse Rescue, and fun riding groups: Huzzies on Hooves.



### **Feeding The Hungry**

Thanks to you – our amazing community sponsors, and tractor and equine participants, the parade has raised over \$27,000! Our beneficiaries – Howard County Food Bank, Carroll County Food Sunday, Farmers and Hunters Feeding the Hungry, and the Lisbon Volunteer Fire Company will be presented checks at the Annual Howard County Farm Bureau Legislative Dinner held on April 20<sup>th</sup>.

In addition, over 3,400 pounds of nonperishable canned foods was collected and donated to feed the local food banks in Howard and Carroll Counties! Thank you to all those who participated in the food drives this parade season!

Since the parade's inception in 2011, over \$177,000 has been raised to feed the hungry! With the generous support of the community, in 2023 the Parade hopes to raise well over \$30,000, bringing that total to over \$200,000!

Maryland Agricultural Education Foundation announces March 20-24, 2023 as the 13th annual Maryland Ag Literacy Week.


With the majority of children today being 3 to 4 generations removed from living and working on farms, we believe that it is crucial to the future success of agriculture for children and adults to recognize and appreciate the importance of agriculture in their daily lives.

MAEF's Ag Literacy Week program focuses on connecting volunteers from the agricultural community to local classrooms with the purpose of increasing student knowledge about agriculture. Each year a new agriculturally-themed book is chosen and an activity developed that reinforces the message of the book. This program educates Maryland youth through the support of volunteers who purchase the agriculturally-themed Ag Literacy Week book to read to elementary students, complete a provided activity with the class and share their personal experiences in agriculture. The book is then donated to the classroom library and the

classroom teacher is given additional lessons to expand the student learning.

Participating in MAEF's Ag Literacy Week is an opportunity for any group or individual wishing to promote and support agriculture to be the face of agriculture in a kindergarten-3<sup>rd</sup> grade classroom across the state.

### Tax Assessment Help

Appeal or Not?

You may want to appeal your assessment, it's not that hard, it's more paperwork, but it may be worth it. Here is a quick look at what I did with the help of a neighbor.

My assessment went from 717,800 to 1,640,000, that was an increase of 923,000, almost double. There is not much you can do about the land, but the buildings are what the biggest increase for us was. They went from 394,200 to 1,187,900.

First, on the back of your assessment is the APPEAL PROCEDURE; follow the directions and get a copy of your Property Worksheet and Sales Listing. Study them and you will be able to see where the increase may be.

Second, make a map of your farmstead buildings, number them and make a description of each one and take a few pictures to match each building for clarity. These buildings are not commercial buildings, they are farm buildings. Some open sided and not heated with running water; all things that would add value but in your case are not. This helps you when you talk to the appeal person.

Third, let them know how old your farm is and the age of the buildings, they are looking at them from the air and don't see the age of the walls or the fact that they are open sided. Also correct any misinformation they may have like decks, porch, stone walls or in my case they thought my house was a two story dwelling.

I have included some info below, as an example that I provided. I know we like to think our farms are really valuable, but this is not the time for that argument.

### ----- Example Appeal-----

January 17, 2022

Ellicott City, MD. 21042

### I am appealing the TOTAL NEW MARKET VALUE because,

- The assessment that has been assigned to our property is over double what it was. I feel the property values have not doubled in 3 years.
- There are no 100-acre properties within several miles of our property for comparison.
- 3) The "Main House" Is over 50 years old, with no where near the value of neighboring residences. The "Barns" and "Out Buildings" are in constant need of repair and up-keep, due to just normal use.
- 4) The fact that we are in "Ag land Preservation", the Zoning Regulations only allow traditional farming practices on the land and that must be something that keeps the value down.
- 5) When the property went into the "Ag Land Preservation Program", we were paid quite a bit less than other properties, because we were on the east side of Rt. 32, for that reason we should be considered less valuable during our assessment process.
- 6) One last fact is that we have no timber to harvest on the property.
